The planned 2023 LLPOA swimming pool hours are as follows [may be impacted by conditions such as inclement weather]:

open Monday – Thursday (12:00 p.m. – 5:00 p.m.) and Friday – Sunday (12:00 p.m. – 6:00 p.m.)

- Members must have paid their membership dues in order to enter the pool area and purchase a pool pass. The member need not be present with their family members, guests or renters if proper form is on file. Please see the enclosed form.
- Children under 16 and those who cannot swim must be accompanied by an adult. We will consider 18 and older as an “adult” for purposes of this rule. ID may be required to demonstrate age.
- Pool membership is offered to Loch Lomond and Cobb area property owners in the pool membership area only [see membership application for membership boundary information].
- Members [property owners] cannot host property owner non-members.
- Each pass is allowed no more than 12 entries per day. Any request for a group larger than 12 will require prior approval and must be approved at least 48 hours in advance. See Website for required form and details at [LLCREOA.com]
